We, the undersigned registered voters of the County of Shelby and State of Tennessee hereby petition the Shelby County Election Commission with the Tennessee Code Annotated 2-5-151-to place on the ballot a referendum question to amend the Charter of Shelby County to be voted on in the Election held of the 7th day of August, 2008.

We request the following question be placed on the ballot.

TO BE COMPLETED BY PETITIONER REFERENDUM QUESTION:

Shall Shelby County Charter be amended to add a new Article VIII entitled "State Constitutional Officers: to provide the duties of the Assessor of Property in Shelby County, the duties of the Sheriff in Shelby County, the duties of the Register of Deeds in Shelby County, the duties of the County Clerk in Shelby County in Shelby County, and the duties of the Trustee in Shelby County, all of whose elections, duties, qualifications, oaths of office, bond requirements and compensation are governed by the Constitution and laws of the State of Tennessee, and whose appointment, in the event of a vacancy shall be filled in accordance with the Constitution and laws of the State of Tennessee. The above named Officers shall remain State Constitutional Officers.
